Dear Mr Davis

Many apologies for turning to you directly. However, the matter which I would like to address, is of some importance and involves an ethical issue related to one of your staff: According to my information Toni J. Taylor, who also uses her married name Toni Horner on occasion, has been employed by Enfield Council. I have been reassured that Toni J. Taylor has also received housing benefit from East Herts Council. Toni J. Taylor had rented my house for almost 18 months between 30 November 2017 to April 2019, until I had to get her evicted. Regrettably she had not paid her rent during the last five to six months of her tenancy, and having been informed that she was still receiving housing benefits, she will have used those funds for other purposes. I have exhausted all other possibilities to encourage Toni J. Taylor to live up to her legal responsibilities and to pay her dept of £7,675.10 (see possession order attached), sadly without success.

I have been advised that councils in the UK do not usually communicate with each other. However, I would be greatly worried, if employees of local councils are committing benefit fraud. Toni J. Taylor has acted in a highly unethical manner and breached dozens of clauses in the tenancy agreement (see document attached). I would be very grateful if you, or somebody else in your organisation, could

encourage Toni J. Taylor to pay her debt as it is stipulated in the court order attached.

I also attach the proof of ID for Toni Jayne Taylor / Toni Jayne Horner. It would be good if justice could be served and your help would be very much appreciated. In the event that Toni J. Taylor does not live up to her legal responsibilities, would you be able to share her postal address with me and / or the bailiffs in charge?
